Combining a defensive baton with the power of a 10,000 volt taser, the Defend Co. Complete Self-Defense Baton is easy to use, and requires no training, allowing you to defend yourself and your family without complication.

• The Defend Co. Complete Self-Defense Baton is shipped in two separate pieces. Upon opening the package, the interior will be separated into two compartments by a cardboard partition. In the left compartment, you will find the hand grip. In the right compartment, you will find the collapsible baton.

Note: If one or both of the compartments does not carry the above-mentioned components, or the components appear damaged, please return the Defend Co. Complete Self Defense Baton to the manufacturer. Defend Co. Products carry a 100 % refund warranty, including compensation for return postage, as well as a promise to exchange the defective unit at no charge.

To Assemble:

- 1. Remove both compartments from the box.
- 2. Check to see if the yellow safety tab is present on the hand grip: this is to ensure that the device is not accidently activated before being properly assembled. The yellow safety tab should be found between the blue and red buttons situated above the grip.
- 3. Upon checking for the yellow safety tab, inspect the collapsible baton. To ensure that the baton is functioning properly, depress two of the four buttons found on the left, right, front, and back of the section labeled "1". If the baton is activated successfully, the remaining two buttons should now be depressed as well.
- 4. Collapse the baton. To do so, press down from the top until the top two sections are firmly secured back into the base. The baton is properly secured once two successive clicks are heard.
- 5. Place the baton inside the top section of the handgrip. The section labeled "1" should be the first section inserted into the hand grip. Continue to insert the baton until three

successive clicks are heard. The third click signifies that the baton is now fully inserted into the hand grip.

- 6. Inspect the baton. If properly assembled, less than '1' inch of the baton's tip should be visible when viewed from the side. If, by your own estimate, more than '1' inch is visible, press the 'release' tab located on the opposite side of the hand grip. Repeat step 5 until less than '1' inch of the baton, when depressed, is visible.
- 7. Remove the cover labeled "batteries" on the bottom of the hand grip. Insert two AA batteries into the compartment, both '+' up. Replace the cover.
- 8. Remove the yellow safety tab from between the red and blue buttons.
- 9. Your Defend Co. Complete Self-Defense Baton is now assembled.

Upon Assembly:

- 1. Press the blue button located near the top of the hand grip. When pressed, the baton should extend immediately upward.
- 2. Once the baton is fully extended, press the red button located beneath the blue button. This activates the baton's taser capability. If the baton is functioning properly, a visible electric current should be seen running the length of the baton, along with a prominent "crackling" sound. WARNING: DO NOT TOUCH THE BATON WHEN PRESSING THE RED BUTTON. FAILURE TO COMPLY WITH THIS WARNING COULD RESULT IN SERIOUS INJURY AND/OR DEATH.
- 3. If the above-mentioned steps are completed without issue, then your Defend Co. Complete Self-Defense Baton is now ready for use.
